We would like to invite all of you to join us in the Inaugural race for the revived Formula One PROP Tour at Port Neches, Tx on April 30<sup>th</sup> – May 2<sup>nd</sup> for the 2010 Riverfest Power Boat Races. Things you need to know:

1. The only legal fuel for F1 & F2 will be Sunoco – fuel will be supplied at the site. Please specify how much fuel you may want on your entry form – sent in advance.
2. Prize money for F1 & F2 will be paid out in accordance with the attached Prize Money payout.
3. F1 & F2 PROP Rules will apply – the Rule Book is available at [www.f1prop.com](http://www.f1prop.com)
4. F1 Competitors must be a member of PROP for the top tier prize money payout. F2 members must be a member of PROP or SPORT for the top tier prize money payout. Please note that all other PROP Tour events F2 members must be a member of PROP for the top tier prize money.
5. All F1 & F2 Boats must have PROP Tour decals displayed prominently on each side of the boat. These decals will be available at the race site.
6. SST-120 and SST-200 will be combined and run for one prize purse. We may score the two classes separately for APBA points – however the final decision on that has not been made yet.
7. Entry form should be filled out in advance and mailed to Sport Marine 3925 FM 359 Richmond, TX 77406. Please specify on entry form how much fuel you want to purchase.
8. PROP Tour Membership Forms should be filled out in advance and mailed to Laurie Allen, 23960 Cedar Ridge Court, Browns Town, MI 48174.
9. Directions – **TRAVELING WEST** - on I-10 towards Beaumont – Take Hwy 73 West to Port Arthur. In Port Arthur take US 69 North to Hwy 365. Turn right on Hwy 365. Follow to dead-end at Port Neches Ave. and turn right. Turn left on Liano. Turn right on Grigsby. Turn left on Merriman and follow to Port Neches Park.  
**TRAVELING EAST** – on I-10 take US 69 South from Beaumont to Hwy 365. Follow to dead-end at Port Neches Ave. and turn right. Turn left on Liano. Turn Right on Grigsby. Turn left on Merriman and follow to Port Neches Park.
